DID YOU KNOW – HOA INFO?

- The HOA developer wrote the covenants for our association, and they have never been updated.
- There are 16 different covenants for different sections of the association.
- To make changes to covenants, we need 75% of homeowners to grant a notarized approval.
- Each year, the budget and new board must be approved by 10% (around 60) of the association homeowners. The approved budget and board allow us to maintain the community and make updates as needed. (This year it took 3 months to get the signatures needed.)
- The Pool Parking Lot is private property and may not be used is not for overnight/ vehicle repairs/ etc. Vehicles may be towed and the lot may be blocked off at any time.

Golf Cart Registration Day at the Pool

A Huntertown Resource Officer will be at the pool between 10:00am-12:00pm Saturday, May 21st to register golf carts! Slow-moving vehicle emblems for \$15.50 will be available for carts that are already registered.

- Proof of Insurance
- \$40 (check or cash)
- Golf Cart



From Huntertown ordinance No. 09-009-Use and Registration of Golf Carts. If you see violations, please call Huntertown at 637-5058.

- Drivers must have valid driver's license and golf cart must be insured! This means drivers must be at least 16 years and 90 days old!
- 2. The *number of occupants* must be *the lesser of* either the manufacturer occupant limit or 6 persons.
- 3. Golf Cart operators must obey all road and traffic regulations.
- 4. All person's age 10 or under shall ride in the front seat.
- 5. Golf carts should have the following:
 - Registration Certificate-All Golf Carts must be first inspected by the Town Marshall, then if approved, registered. Registration fee must be paid.



Huntertown Stats

As of 2000 the median income for a household in the town in 2000 was \$52,250, and the median income for a family was \$59,219.

Males had a median income of \$41,150 versus \$28,152 for females. The per capita income for the town was \$21,232.

About 3.0% of families and 4.2% of the population were below the poverty line, including 6.1% of those under age 18 and 6.3% of those age 65 or over.

SPRING REMINDERS!

Pets

- 1. Pick up after your dog (scoop poop) when on walks.
- 2. Keep your dog on your property unless they are on a leash.
- 3. If your dog is barking, bring it in! Dogs are pack animals and you are their pack!
- 4. Cats are NOT allowed to roam off their property in Allen County (Ordinance 8014-2-1).

Neighborhood

- 1. Keep your eyes open! If you see street lights burned out, mailboxes in disrepair, garbage or muskrats near the ponds, pool shenanigans, etc., please call Above and Beyond.
- 2. The speed LIMIT is 30mph. Please drive slowly through the neighborhood!
- 3. NOTHING should be in common areas unless approved by board!
- 4. You can operate a business in the home, but it cannot affect anywhere or anything outside of the home. *There should be NO HINT from the outside that you have a business inside!*

Home Responsibilities: Keep your home looking nice!

- 1. Keep your yard mowed, maintained, and clean of debris.
- Wash mold and algae off from your house, and install pest-guard covers over exterior vents to prevent birds from getting into your attic.
- 3. Check sump pumps and move output drainage hose if it is causing erosion to common areas.
- 4. Repair / repaint fences and garage doors (don't forget to check the garage door molding!)
- 5. Trailers, utility trucks, and boats cannot be parked ungaraged for more than 48 hours.

- **5.** Repair fences, and reroute sump pumps to prevent erosion to common areas. Keep your dog on your property, unless leashed.
- **6.** Keep your eyes open! If you see street lights burned out, mailboxes in disrepair, garbage or muskrats near the ponds, pool shenanigans, etc., please call Above and Beyond!
- **7.** Move it! Trailers, utility trucks, and boats cannot be parked ungaraged for more than 48 hours.
- **8.** Pick up after your dog when on walks.



Pond News

The Preserves entrance pond has had brush removed and riprap placed! It looks beautiful! The southmost pond in Carroll Creek should be done in November, also with brush removed and riprap placed. Pool

I know, right? Pool talk in November?

Earlier this year, the board approved opening the pool an hour earlier (from 10am to 9am) for the 2023 season.

Extending the pool season, however, is dependent on the weather and the pool person's availability. Attend the April 2023 Open meeting for more discussion.

INDIANA TRIVIA

- The Northern Indiana landscape is physically characterized by very flat to very rolling terrain, ranging from 600 to 1,000 feet (180 to 300 m) above sea level.
- Kosciusko County is home to the largest natural lake (Wawasee) and deepest natural lake (Tippecanoe) in Indiana.
- Northern Indiana is known for having the third-highest Amish population in the U.S., especially in Allen, Adams, Elkhart, and LaGrange counties.
- Because of the city's transitional location between the Inland North, North Midland, and Central Midland dialects, Fort Wayne been difficult for linguists to define, with some labeling speech here "virtually accent neutral," attributed to historical settlement patterns.
- Most of the state's rivers flow south and west, eventually emptying into the Mississippi. However, the Maumee flows north and east into Lake Erie.
- No other place in the world has more covered bridges than historic Parke County. There are 32 covered bridges in that county alone. That's why Indiana is considered the "Covered Bridge Capital of the World."
- We wouldn't be able to pump gas into our cars if it wasn't for Fort Wayne's Syvanus F. Bower. He was the inventor of the world's first gasoline pump.
